  - 2. Wrestling
    - Wrestler of Year (plaque vote by coaches); COY (plaque to winning coach); Winner of each weight class (medals)
    - Wrestling Tournament Still only Boys Championship, but girls can wrestle in the Boys Championship; no Junior High meet; Fort Frye is the host & will run 2 mats with 3 officials.
